

## Keynotes: Epistemic in/justice and the right to health: multiplying the ontologies of health status Monica Greco (Goldsmith/UK)

The presentation discusses the affordances of the concept of epistemic in/justice, and its multiple variations, for understanding the stakes of the HIV/AIDS epidemic in connection with the 'right to health'. Epistemic injustice has been thematised in relation to HIV/AIDS primarily in two ways: in relation to social perceptions of HIV and the problem of HIV transmission; and in relation to the status of indigenous healing practices in the context of the South African epidemic. Each of these problematics invites us to experiment with what it might mean for a 'right to health' to extend to 'health status'.



### Keynote: Civil Society & HIV/AIDS in Russia Ulla Pape (Freie Universität Berlin/Germany)

This keynote addresses AIDS activism in post-Soviet Russia, where annual rates of new infections continue to grow at an alarming rate. The presentation will explore what it means to be an AIDS activist in today's Russia. Central is the question when, under which conditions and why people come out as HIV-positive, which in Russian language is described as "living with an open face". Russian AIDS-activism is closely linked to empowerment, overcoming stigma and advocating for the social rights of those affected. To better understand this activism, the course of the epidemic, HIV-related stigma in Russian society, and the inadequate government and civil society responses will be discussed.










#### Upcoming: Exhibition ,,HIVstories: Living Politics"

How are biological and social lives shaped by policies and politics in the context of HIV/AIDS? How do state and activist policies negotiate positive bodies and those at risk? And what does an AIDS activist life look like? The exhibition takes place in Berlin from September 12th till November 12<sup>th</sup>, in cooperation with the city's prestigious Schwules\* Museum. consists of a curated selection of artworks, artefacts and oral histories different European regions. Visitors are challenged to consider how multiple forms of citizenship take shape through engagements with HIV/AIDS policies and marginalized bodies in Europe.



#### Meet Aper Turan

Alper Turan is a new member of the EUROPACH team. He works together with on the exhibition in Schwules\* Museum and we are very happy to have him onboard. Turan is a freelance curator and co-founder of curatorial collective Das Art Project. Recently he curated the group exhibition Positive Space, a project on HIV/AIDS in Turkey which brought together artistic seropositive productions of negative artists with the aim exploring the possible meanings of HIV in Turkey. The project took place in the Operation Room, a gallery space attached to a private American Hospital Istanbul. Artworks from this exhibition will be listed in our art archive that you can visit on our website and some will be cohabited as part of the "HIVstories" exhibition

#### Intro to our HIV/AIDS Art archive

Throughout the course of our project, we created a collection of artworks from across Europe that engage with the topic of HIV/AIDS. We consider art to be an important part of how our social world is formed, influencing both policies and activist work often by illustrating stories and perspectives from the margins. Research about the work of artists as activist mediators in Europe has received meaningful but only scattered attention. With the creation of this archive, we thus hope to facilitate new appreciation for the importance and impact of artists and art. The two pieces of art work that we move on to introduce to you "Tab" and "Powerless Structures" are two examples of art works that will be listed in our repository from the exhibition Positive Space curated by Turan. #### Tab by Furkan Öztekin

Furkan Öztekin' collage series solidifies an online search for AIDS visuals. Copied, recorded, created images come together and contaminate each other; become as neutral as a virus, mixing positive and negative spaces of the conventional visual composition. Öztekin hides the faces and identities; in order to accentuate the invisibleness.

### Powerless Structures, Fig. 19, 1998 by Elmgreen & Dragset



Elmgreen & Dragset's work shows two pair of jeans simply left on the floor in front of a partition. It symbolizes both the homosexual body in Turkey as marked by the absence of tacit bodies, and eroticism in the invisibility of bodies. The two naked non-present bodies are either together having fun in the dark space starting after the screen or they are simply disappearing into it.




#### New: Policy map HIV/AIDS and De/Criminalisation

The unfolding of the epidemic in various European regions has been closely entangled with processes of criminalisation and decriminalisation. We developed an interactive policy map for researchers, activists and advocates to dig deeper into crucial events and central conflicts. We invite you to follow the conflicting and sometimes mutually supporting arguments and logics that make up the five different cases of de/criminalisation: the European Human Court of Human Rights case negotiating sex work, drug use and migration; the introduction of harm reduction in Poland; needle exchange programmes in German prisons; HIV transmission and related policy issues in the UK and in Turkey. #### Witness seminars: now available online

The texts produced from the witness seminars that Emily Jay Nicholls and Marsha Rosengarten held as part of the UK component of EUROPACH are now available online. A witness seminar sits between a focus group and an oral history, where people who were involved in a particular issue or event come together to tell its story collectively. Four witness seminars were held on the topics: Antiretroviral Drugs up to and including the Proposition of TasP and PrEP, the Criminalisation of HIV Transmission, HIV Prevention and Health Promotion and women and HIV.
